

VisitorPoint Privacy Policy

Because we want to demonstrate our commitment to our users' privacy, we disclose the following information.

1. What personally identifiable information VisitorPoint collects.
2. What personally identifiable information third parties collect through the Website.

Information Collection and Use:

VisitorPoint is the sole owner of the information collected on our website(s). VisitorPoint collects information at several different points on our website(s).

Information is collected for the purpose of providing the services and products offered by this website(s). Users have the option to participate in this activity for the purpose of contacting by email or regular mail. A user must provide the clickstream information (internet protocol address, internet service provider, platform type, date/time stamp, operating system), state management mechanisms (data allowing a user to be tracked consistently), search terms (search text), transaction information (account transactions), user's name, user's login information, user's home contact information and user's business contact information. The reason we use this information is to complete the current transaction, contact by email or regular mail, enhance our site(s) and product offerings, enhance your experience by customising our site(s), maintain and secure our site(s), understand (in aggregate) interests of website(s) visitors and understand your interests. We retain this information as stated by our business practices.

Cookies:

A cookie is a piece of data stored on the user's computer tied to information about the user. For the session ID cookie, once users close the browser, the cookie simply terminates. A persistent cookie is a small text file stored on the user's hard drive for an extended period of time. Persistent cookies can be removed by following Internet browser help file directions. You can set your browser to notify you to either accept or deny the cookie.

Profiles:

VisitorPoint uses data to create a profile of our users. A profile is stored information that we keep on individual users that details their viewing preferences. Consequently, collected information is tied to the user's personally identifiable information to provide offers and improve the content of the site for the user. This profile is used to tailor a user's visit to our website(s), and to direct pertinent marketing promotions to them.

Communications from the Site:

When customers provide us contact information for the website(s) (user participation is voluntary) we use the information to contact the user to deliver sales and product information that may be useful to them.
